<u>Project Description:</u> Northwestern Oklahoma State University requests ratification of emergency approval given on August 11, 2017, by Regent Reilly (Facilities Stewardship Chair) and Regent Stansberry (Board Chair) to change the construction manager for the student center renovations from American Construction Services, LLC, to Shrader & Martinez Construction, Inc. The original project was approved at the June 22, 2017, RUSO Board Meeting. The information below was approved at the June meeting and has not changed.

Chickasaw Nation Governor Bill Anoatubby will deliver the Tuesday evening keynote address shortly after dinner. Anoatubby will be introduced by Chancellor Glen Johnson, of the Oklahoma State Regents for Higher Education. Featured speakers for Wednesday, Oct. 11 include Dr. David Zoldoske, Executive Director of Water Initiatives at California State University-Fresno.

President Pierson reported that ECU has earned the Higher Learning Commission Quality Initiative Open Pathways accreditation without qualification. It is an improving institution support accreditation such as a comprehensive look at technology, 24-hour lab access for students, etc.,.

President Pierson reported that 200 ECU employees participated in the Disney Institute's Approach to Quality Service Seminar on September 8, 2017. The event focused on Disney's approach to customer service.

President Pierson reported that ECU's Global Study Abroad Program now includes the University of Limoges in Limoges, France and the University of Applied Sciences in Biberach, Germany where students can earn a diploma or certificate from either institution.

#### D. UNIVERSITY OF CENTRAL OKLAHOMA

(See attachment F, Pages 101-112)

Regent Reilly made the motion, seconded by Regent Dunn, to approve the President's Recommendations for the University of Central Oklahoma as presented by President Don Betz.

President Betz reported that UCO once again ranked as the top public regional university in the state on the 2018 Best Colleges list from U.S. News & World Report. UCO ranked number 25 in the list of Tier One institutions in the "Top Public Schools: Regionals Universities—West category and number 76 in the regional universities in the west. That is up from number 32 on the Tier One list and number 88 on the overall list in 2017.

President Betz reported the UCO School of Music hosted the grand opening of the Mitchell Education Center on August 31, 2017. It is a 17,000 square-foot addition to the historic Mitchell Hall Theatre.

President Betz reported that the American Association of State Colleges and Universities (AASCU) named UCO as one of its 2017 Excellence and Innovation Award winners. UCO was recognized with the Student Success and College Completion Award, specifically for the creation and continued efforts of its Black Male Initiative which addresses the retention and graduation rates of African American men at UCO. The program offers peer mentoring between Black Male Initiative freshmen and the upper classmen.

President Betz reported that the National Cancer Institute of the National Institutes of Health awarded Dr. Wei Chen a five-year Research Project Grant (R01), totaling \$1,374,355 to support the continuation of his long-term work on his unique cancer treatment method, Laser Immunotherapy. UCO is the only non-research institution in Oklahoma to receive NIH R01 funding.

President Betz reported that as part of UCO's mid-cycle Assurance Review from the Higher Learning Commission (HLC), they have earned an unqualified recommendation from an HLC peer review team, indicating that UCO has met all review criteria. The review's conclusion is expected to be finalized later this fall.

#### E. SOUTHWESTERN OKLAHOMA STATE UNIVERSITY

Regent Ford made the motion, seconded by Regent Carpenter, to approve the President's Recommendations for Southwestern Oklahoma State University as presented by President Randy Beutler.

Dr. Landry reported that NSU has partnered with the Grand River Dam Authority (GRDA) to provide opportunities for faculty and students to do research related to the Illinois River. The partnership will help fund student scholarships as well as a variety of research opportunities including in-class projects and independent research.

Dr. Landry reported that the ribbon-cutting for the newly remodeled Playhouse will be happening November 8, 2017 and that formal invitations will be sent out to the Regents.







The recommendations of East Central University are as follows:

#### I. PERSONNEL

#### A. FACULTY APPOINTMENTS
