2. Presentation by USI of fiduciary oversight review of 403(b) plan for quarter ending March 31, 2018 and possible action on investment changes.

Investment Consultant Teddie Grant provided written report (see attachment B) and reviewed the economic review, plan assets and fund performance, and identified potential addition to investment choices.

3. Discussion and Possible Action on hiring USI Consulting Group as consultant for the 457(b) plan.

5. Review of Pension and Other Post-Employment Benefits Actuarial Valuations by USI.

Timothy R. Ryor reviewed current actuarial evaluations of RUSO's Supplemental Retirement Annuity plan (SRA) and Retiree Medical Plan (OPEB) and provided next step options (see Attachment C).

- Supplemental Retirement Annuity (SRA) plan assumptions are not properly aligned with Oklahoma Teachers Retirement System assumptions.
- SRA asset allocation is not aligned with target date for fully funded status.
- Advisor/actuarial/custodian fees for SRA are high.
- TIAA limits withdrawals on traditional accounts to 10% per year over a ten-year period, which may limit SRA options going forward.
- Assumptions aligned better on the Retiree Medical Trust (OPEB).
 - 6. Discussion and possible action to terminate relationship with TIAA for consulting services on Supplemental Retirement Annuity and replace with USI for consulting services on Supplemental Retirement Annuity.

Timothy R. Ryor of USI Consulting Group advised on steps recommended to terminate relationship with TIAA:

- Have conversation with TIAA about withdrawal of assets without application of 10% per year limit.
- Create a trust and find new custodian.
- Retain new consultant/investment advisor.
